Infrastructure:	Jerry Seymour, Mayor, exclaims that he intends to fix Citty, Kay and Christina Drives this summer.
Building Grant:	The Mayor said another \$13,000 is coming and that will be the last of the \$125,000. Jerry still would like to fix the siding, landscaping, and possibly install air conditioning with the rest of the grant money the village needed to pitch on.
Sign:	Ellen Bowe states she is very pleased by the sign despite her previous skepticism.
